One Pranab Banerjee, Inspector of Police, West Bengal s/o Lt Ganga Charan Banerjee of Garia Station Road, PS Sonarpur, District South 24-Pgs c/o Sri Tapasendra Mukherjee, Khandapara, PO Birnagar, PS Ranaghat, Dist Nadia was convicted u/s 302 IPC for life imprisonment in c/w Jadavpur PS c/no 12(7)76 by the Ld. Addl Sessions Judge, Alipur for the charge of murder of his wife. He was lodged in Central

Jail, Alipur. He managed to get release on bail submitting forged and fabricated documents and is absconding ever since. A case vide RC 2/S/87/SIC-I, u/s 420/465/466/468/471 IPC was started against him by CBI, SCB, Kolkata. The Ld. Court has declared him absconder as he has been evading arrest. 3. One UTP Jitender Kalu s/o Samay Singh (40-45 yrs) of village Wazirpur, Delhi who was taken to AIIMS Hospital, New Delhi for medical check-up under police escort has escaped on 15/07/04 from police custody. He is involved in two murder cases and one attempt to murder case of police station Keshav Puram Mukherjee Nagar and Model Town respectively. Ref. IB, WB Org No 3737(30)-320-2003 (Part – II) dated 21/07/04.
4. One Kalimuddin Md @ Kailu Sowant, Manager of Goodwill Enterprise, PS Jorethang, South Sikkim had stolen away cash Rs 3,20,000/- only by breaking open the office of the Manager on 5/6/04. After commission of crime he fled away towards Islampur, U/Dinajpur, his native place. Raid was conducted at Khabargaon Bodha Busti under PS Islampur, Dist U/Dinajpur and cash Rs 53,382/- was recovered from his house. However, till date the accd could not be apprehended nor the rest stolen cash could be recovered.

The Padmanabhiah Committee on police reforms has laid stress on timely collection of intelligence by the officer in charge of PS who have thus been designated as principal intelligence officers within their jurisdiction. For this purpose, the officer in charge of the PS is directed to nominate one of his junior officer for collection of intelligence from subordinate police personnel in respect of 1) incidents likely to lead to communal disturbances, 2) suspected movement of militants/extremists, 3) suspected activities of organized crime, 4) emergence of sleeper cells of terrorist outfits, 5) arrival of unknown persons in the locality, inputs on likelihood of natural calamity etc. The nominated officer will thereafter submit his report to the PIO.

Intelligence so collected by the PIO should then be sent to the district Superintendent of Police, who in turn, after due consideration, depending on the importance of the inputs, will forward the same to the Police Directorate (attention IGP (L & O), with a copy to IB Hqrs for further necessary action. The superintendent of Police will also make a special mention of such intelligence inputs received from the PIOs and action initiated thereon, in their monthly DOs to the DG & IGP, West Bengal
