**(4) Interesting detections by CID, West Bengal**

1. On 18/4/04 on a secret information DDI Purulia organised raid and seized 19 Nos Pirated CDs including 2 blue films from the Video Library styled as Kalyan Subhajit Electronics at Purulia Town. The owner Kalyan Dey has been arrested. This refers to Purulia Town PS c/no 31 dt 17/4/04 u/s 63/64/68 Copy Right Act and 292 IPC.
2. On 20/4/04 in between 19:10 hrs and 20:05 hrs in persuance of source information Dy SP, WG Cell CID, along with his staff organized raid at platform No 9 of Howrah Railway Station and arrested three accuseds viz (1) Sakti Pada Sarkar s/o Joyanta Sarkar of 5 No Jari Jangule, PS Sandeshkhali, North 24 pgs (2) Basanti Sarder d/o Joyanti Sardar of do (3) Smt Laxmi Mondal w/o Lt Sailendra Mondal c/o Chittya Ranjan Mondal of Pardhara, PS Hingalganj, North 24-Pgs. Eight victim girls were recovered when the accused persons were trying to take them to Delhi for some illegal motives. Eleven Railway Tickets and Eight Bus Tickets were also seized from their possession. This refers to Howrah GRPs c/no 76 dt 20/4/04 u/s 363/366A IPC.
3. On 24/4/04 around 11:00 hrs acting on a secret information DDI Barasat and staff organised a raid on Jessore Rd and arrested one Abir Chatterjee @ Pole @ Pappu s/o Joytirmoy Chatterjee of Hridayapur PS Barasat with one single shoter fire arams. This refers to Airport PS c/no 66 dt 24/4/04 u/s 25/27 A Act.
4. On 12/5/04 in persuance of a secret information a raid was organized at Rosa Road South, PS Jadavpur by the officers and men of SOG CID, WB and arrested (1)Tapan Bose of Sreepally, Purbaputiary, PS Regent Park, Dist South 24-Pgs. (2) Biswanath Roy s/o Haripada Roy of do and recovered one manuscript written by Kabiguru Rabindranath Tagore in Japani Script with its translation in Bengali. Following the statement of the accused persons another accused viz (3) Pintu Pandey s/o Lt Gostha Behari Pandey of 2C Shyama Prasad Mukherjee Road, PS Bhabanipur, Kolkata was arrested. On the same day under direct supervision of SS(N) CID, WB and DS SOG, CID WB the accd (4) Dwija Das Banerjee s/o Lt Tarapada Banerjee of Flat No 13, 4<sup>th</sup> floor, LM Co-operative Housing Society 49B, Southern Avenue, PS Tollygunj, Kolkata, (Retired Register Biswa Bharati University) was also arrested. This refers to Jadavpur PS c/no 176 dt 12/5/04 u/s 379/411/414/424 IPC & 25(1) Antique and Art Treasures Act 1972.

5. On 26/5/04 at 13:30 hrs DDI Siliguri received an information that some unscrupulous persons are illegally dealing with LPG at various places of Siliguri Town. The persons transferring LPG from Big Cylinders meant for genuine customers to small cylinder of 2 kgs, 5 kgs and 6 kgs with the help of some devices. Accordingly DDI Siliguri with staff organized raid in various places including Chayanpara under Bhaktinagar PS, Dist Jalpaiguri and recovered 55 pcs of 2 kgs small cylinder filled with LPG and 82 pcs of empty small cylinder with some implements used for transferring the LPG from one cylinder to another. This refers to Siliguri PS c/no 187 dt 26/5/04 u/s 379/441/420 IPC, R/W section 9(B) IE Act, 7(11) EC Act 1955.
