(D)(i) Property lost, stolen or seized on suspicion.

1) On 14/04/2009 around 19:00 hrs while one Mostafizur Rahaman of Habra Mohammadpur, PS & District-Malda was returning to home from Bibigram on the way near Jhimulia Narayanpur-Balatali Road by the red coloured Pulsar Motor Cycle bearing no. WB-66D/9727, 4 unknown miscreants stopped him and snatched away cash Rs. 8000/- , one Nokia-1110 mobile set and his Motor Cycle after tied him with gamchha. This refers to Malda PS Case No. 86 dated 14/04/2009 u/s 392 IPC.

2) On 12/04/2009 around 21:00 hrs a theft was committed by one Anik Maity (servant of one Amiya Nandi of Litunia, PS -Salboni) s/o Swapan Maity of Raipur, PS -Debra in respect of cash Rs. 1,70,000/- from his ownership. This refers to Sabong PS Case No. 30 dated 14/04/2009 u/s 381 IPC.

3) On 11/04/2009 around 12:05 hrs a theft was committed by some unknown miscreants in respect of cash Rs. 2,08,000/- from Sukhiapara area. This refers to Jagaddal PS Case No. 166 dated 15/04/2009 u/s 379 IPC.

4) On 18/04/2009 around 03:30 hrs one Monoj Kumar Paswan of Salimar , PS-Shibpur, District-Howrah alongwith the driver of the Truck Swaraj Yadav were proceeding from Durgapur towards Dankuni side along Durgapur Express Way loaded with 11.280 Tons of TMT Bars. They halted at EKTC Hotel under Dadpur PS to take their meals. After taking the same while they were returning , 6 unknown miscreants boarded the Truck and started to assault them. The helper managed to escape and the miscreants flee away with the loaded Truck and driver. This refers to Dadpur PS Case No. 56 dated 18/04/2009 u/s 395/397 IPC.

5) On 17/04/2009 qaround 05:30 hrs. a theft eas done by some unknown miscreants in respect of Cash Rs. 1,30,000/- from the sweet shop of one Dulal Nandi of Durgapur at Karandighi Surya More. This refers to Karandighi PS Case No. 127 dated 20/04/2009 u/s 379 IPC.

6) On 20/04/2009 around 11:00 hrs while one Jayanta Barman of Mill Road was returning to his house from Petrol Pump with cash Rs. 1,25,000/- (approx) as sale money in a bag , then 6/7 unknown miscreants being armed with fire-arms and bombs attacked and looted away the said amount of money from his possession after exploding a bomb. This refers to Falakata PS Case No. 145 dated 21/04/2009 u/s 395/397 IPC and ¾ ES Act.

7) On 24/04/2009 between 01:00 hrs and 04:00 hrs a theft was committed by some unknown miscreants in respect of Cash Rs. 1,50,000/- , one silver chain and one pair of gold

ring etc. from the house of one Monoj Kr.Yadav of Khaldhar. This refers to Titagarh PS Case No. 151 dated 24/04/2009 u/s 380 IPC.

8) On 25/04/2009 around 23:30 hrs., 7/8 miscreants being armed with the firearms and bombs entered into the office room of Shyam Auto Mobile (Petrol Pump) at Hat –Asuria More and looted away cash Rs. 46,632/- , one mobile phone and some papers etc. from the said pump. The miscreants also snatched away Cash Rs. 15,000/- and 5000/- from the drivers of two trailers. During operation miscreants also looted away SBBL gun from the Gunman. This refers to Barjora PS Case No. 42 dated 26/04/2009 u/s 395 IPC , 25/27 Arms Act & 9(b) IE Act.

9) On 25/04/2009 around 11:30 hrs , 2 unknown miscreants snatched away cash Rs. 5,25,000/- from one Suresh Prasad Singh , an employee of Jenises Company, Cheliadanga from near his office. This refers to Asansol South PS Case No. 102 dated 25/04/2009 u/s 392 IPC.

10) On 24/04/2009 night, theft was committed by one unknown miscreants in respect of 13/15 bharis of gold ornaments, 10/12 bharis of silver ornaments (approx) and cash Rs. 10,000/- from the house of one Biman kumar Sen of Mahodi. This refers to Labpur PS Case No. 56 dated 27/04/2009 u/s 461/379 IPC.

11) On 27/04/2009 around 05:30 hrs a theft was committed by one Pradip Berhua, Manager of Sujata Protein Food Products Limited of Panihati, Aswini Dutta Road, in respect of Cash Rs. 1,60,000/- from said company. This refers to Khardah PS Case No. 208 dated 27/04/2008 u/s 381 IPC.

12) On 28/04/2009 noon, a theft was committed by some unknown miscreants in respect of some cash and gold ornaments which valued Rs 2,00,000/- (approx) from the house of one Sanatan Banerjee Katjuridanga, Milan Pally. This refers to Bankura PS Case No. 109 dated 28/04/2009 u/s 380 IPC.

14) On 03/05/2009 a theft was committed by some unknown miscreants in respect of silver made Idols of one “ Sree Ganesh”, Sree Laxmijee” and “ Sree Krishnaje” from the house of one Sajon Kr. Agawal of 1A-215, Salt Lake. This refers to Bidhan Nagar (South) PS Case No. 63 dated 03/05/2009 u/s 380 IPC.

15) On 26/04/2009 a theft was committed by one Hasim Khan s/o Alauddin Khan of Dhamaiknagar, Rajaniganj, PS- Mahishadal , District- East Medinipur and one other both of employees of one Sk. Abdul Gani of W -65/1 , Hazi Ratan Lane in respect of cash Rs. 83,000/ - and some gold ornaments from his house. This refers to Nadial PS Case No. 22 dated 03/05/2009 u/s 381 IPC.

16) Between 15/04/2009 and 03/05.2009 , a theft was committed by some unknown miscreants in respect of small brass made Idols of “ Goddess Lakshmi” “ Lord Narayana” , “ Goddess Saraswati” and “ Lord “ Ganesh” , other household articles and cash Rs. 40,000/- from the house of one Jhumur Chakraborty (Advocate of High Court, Kolkata) of Andul Purbapara. This refers to Sankrail PS Case No. 181 dated 03/05/2009 u/s 457/380 IPC.

17) On 03/05/2009 around 14:00 hrs , one Sk Yasin Gena s/o Sk Mushia of Baharal , PS- Ratua and 5/7 other unknown miscreants snatched away one Motor Cycle No. WB-66/7191 and cash Rs. 1,75,000/- (approx) from one Sunil Prosad Keshori of BS Road PS Englishbazar while he was returning to home on way between Baharal and Raghabbiti after assaulting him with the knife and gun. This refers to Ratua PS Case No. 135 dated 03/05/2009 u/s 395/397 IPC.

18) On 03/05/2009 around 23:30 hrs 6/7 unknown miscreants administered unknown poison in a soft drinks to the driver and khalasi of Truck No. WB23 -3086 and took away the Truck loaded with 67 Jute Belts towards Chakdah. This refers to Gangnapur PS Case No. 89 dated 04/05/2009 u/s 328/395 IPC.

19) On 04/05/2009 3 unknown miscreants came to JM Service Station, Srirampur , PS- Debra by the side of NH-06 with Hero Honda M/Cycle and drew full tank Petrol there and suddenly attacked the oilman and assaulted the son of the owner of that petrol pump by using

butt of revolver and robbed away cash Rs.2,10,963/- and one mobile phone and fled away towards Panskura side. This refers to Debra PS Case No. 54 dated 04/05/2009 u/s 394 IPC and 25/27 Arms Act.

20) On 05/05/2009 around 01:30 hrs, a theft was committed by some unknown miscreants in respect of cash Rs. 75,000/- and 10 bharis of Gold ornaments (approx) from the shop of one Samir Roy of Boslabari, PS-Kotwali , District-Cooch Behar styled as “ Santoshi Maa Gold Ornaments” at Sonapur Chowpathi. This refers to Alipurduar PS Case No. 231 dated 05/05/2009 u/s 461/379 IPC.

Ransom was demanded over phone to the family members and ultimately the victim was released on 02/08/2001 after paying Rs. 3.75 Crores as ransom. This refers to Tiljala PS c/no 223 dt 25/7/01 u/s 364A/307/120B/34 IPC & 25/27 Arms Act. The case ended in Charge Sheet showing 7 persons as absconders on 30.05.2002.

The case was tried in the Court of Ld. 2nd Additional District Judge, Alipore. The core criminals namely 1. Aftab Ahmed Ansari 2) Akib Ali Khan 3) Saukat @ Asabuddin 4) Abdul Rahaman Kunji and 5) Happy Singh were sentenced and convicted for life imprisonment on 20/05/2009. Another 7 accused persons were in different Correctional Homes outside the State of West Bengal at the time of trial of 1st phase. Their case was split up. Trial in the 2nd phase of these 7 accused persons will commence soon.

2) One Smt Priti Sing w/o Firoz Singh of PhataPukur , PS: Rajgunge Dist. Jalpaiguri was tortured by her Husband and compelled to leave her sucking male Baby at Jalpaiguri in her in laws house. under this circumstances as desired by the Women's Commission WB a team of POWC cell

went to Jalpaiguri and contacted the local police along with the mother and brought back the baby in order to Make over the baby to her mother's lap. This refers to Bijpur PS GDE No. 247 dt 4.5.09

The difficulty in this incident was that no case was started against any person as per desire of the mother, but side by side the mother wanted back her child frantically. Another difficulty was that The Phatapukur area of Rajgunj PS is mostly dominated by minority and they are governed by their own law and rituals. so the team of POWC had to be very much cautious in their movement in order to maintain public tranquilly and keep eye on law and order Situation. the team recovered the baby on 26.5.09 and came back to kolkata immediately.

3) One Victim girl of Picnic Garden Rd was allured by one Mani Ali @Mamoni and one Raj on pretext of good job and took victim to Goa Via Bangalore. The victim was minor and was missing from 16.2.09 evening. During a petition enquiry, it was learnt that one perpetrator namely Mani Ali Went to Bangalore leaving the Victim with Raj at Goa. Subsequently during enquiry Mani Ali could Be traced at Bangalore by POWC cell using their own network and managed to brought back Mani Ali and get her arrested by Kasba PS.POWC cell also traced the victim girl at Goa with the help of Mani Ali. Subsequently the victim was rescued by Kasba PS depending on the information conveyed by POWC cell. This refers to Kasba PS case no.81 Dt.11.3.09 u/s 363/366 IPC. The difficulties in this case was that to trace the perpetrator Mani Ali whose where about was not known even to IO of this case. It was only known to CID that Mani Ali might have been at Bangalore. With little knowledge POWC could able to find the accused Mani Ali at Bangalore and after that, helped Kasba PS to rescue the victim. So, depending on the Information given by POWC cell, CID this case was solved.

4) During a petition enquiry, endorsed by the Superior Officer of CID, West Bengal, it was found that one minor victim d/o Jatin Gharami of Simulpur, PS - Gaighata was allured by one Sujoy Biswas of Habra and took her along with him to Mumbai and allegedly sold the victim. The relatives of victim were contacted and it was learnt that she phoned from one PCO in Nalasopara area of Mumbai. This refers to Gaighata PS case No. 222 dt.30.4.09 u/s 363/366A/372 IPC. The difficulties in this case was that the where about of the victim was not exactly known as the victim could not name the place from where she was talking to her family. Subsequently, working on the telephone no the name of The place at Mumbai was learnt and source was engaged with the help of a Mumbai based NGO. She is being tracked by the NGO concern and soon to be rescued.

5) On 27/05/2009 officers and men of Cheating & Fraud Section, CID, West Bengal arrested two important accused persons namely 1) Kartick @ Panchu Mondal s/o Lt. Bishtupada Mondal of Shikharpur, PS Rajarhat and 2) Sukur Molla s/o Late Afsan mOlla of Lauhati, PS Rajarhat both of North 24 Parganas ditrict in c/w East Bidhannagar PS Case No. 127 dated 23/09/2008 u/s 406/420/467/468/419/471/120B IPC.

6) In pursuance of a secret source information, Officers and men of SOG Section, CID, West Bengal held raid on 09/05/2009 at 13:10 hrs. and arrested 2 accused persons namely 1) Md. Mustafa Sk (27) @ Rabi s/o Md. Najrul Islam of Bayna, PO-Sekhalipur, PS-Lalgola, District- Murshidabad and 2) Abdus Nazibur (37) s/o Lt. Abdul Sattar of Natun Bayra, PO-Sekhalipur, PS-Lalgola, District-Murshidabad and seized Rs. 1,00,000/- FICN from their possession. This refers to Tiljala PS Case No. 152 dated 09/05/2009 u/s 489B/489C/120B IPC.

7) On 08/05/2009 at late night one Sri Barun Kumar Dey (Advocate of Alipur Court) had been missing on the way to his residence at Budge Budge after taking departure from the residence of his colleague Sri Saikat Dutta Majumder (Advocate, Alipore Court) at 23:30 hrs. Later, on 09/05/2009 morning the dead body of the victim was recovered from the side of a

pond located at Panchlabati, Malancha by the side of NSC road, PS- Sonarpur, District-South 24 Pargana. This refers to Kasba PS Case No. 17 dated 10/05/2009 u/s 364 IPC & adding section 304A/302/201/34 IPC. The control of the investigation was assumed by CID, West Bengal.

During investigation it could be learnt that he availed shuttle taxi , WB-04B-0459 from Taratala More on 08/05/2009 at 23:55 hrs. He was strategically murdered by the culprits who were also sitting in the said vehicle in disguise of co-passengers. The dead body was disposed of by the culprits in the above noted place after murder. The culprits were identified and arrested and the vehicle ie shuttle taxi WB04-B-0459 was recovered on 21/05/2009 by the officers and men of SOG Section,CID,West Bengal, leading to the statement of the arrested accused persons.

8) CID, West Bengal Missing File No. 55-2009/ 4/ F(8) dt. 06-05-09 was opened over the missing of one Pinki Singh D/o Bijoy Singh of Ramrajatala Station Road, PO -Santragachi, PS – Jagacha, Dist – Howrah on receipt of a petition from the father of the missing girl. All informative action were taken accordingly. As per secret source information, MPB,CID came to know that the missing girl stays at Gulbarga, Bangalore, Karnataka. A letter was issued to Superior authority of Karnataka Police and the local PS. Petitioner Bijoy Singh met with her daughter (Pinki Singh) there who was already married to that boy from whose phone she talked to her father.Thus by dint of sincere effort from the part of MPB Section the missing girl has been recovered from Bangalore city and restored to her parents.

9) CID, West Bengal Missing File No. 55-2009/ 5/ F (5) dt. 04-05-09 was opened over the missing of a minor girl Sayani Chattopadhyay D/o Debasish Chattapadhyay of Vill +po-Kanubanka, PS – Dhaniakhali, Dist – Hooghly. All informative actions were taken as per existing system. Then after interrogating the father of the missing subject some phone numbers were collected. By chasing the phone number the tower location was detected at Kotolpur, Bankura. It was also ascertained that the minor missing girl had left home with a boy who leaves at an adjacent village. Both of them developed a love affairs. The guardians were informed accordingly who rush to Bankura and traced out the girl.
