Order passed by Hon'ble J. Altamos Kabir and his complaint J.Cyriac Josheph of Supreme Court of India in (2010/46 OCR (SC)-672

Synopsis of the order:-

- a) No application for Police remand can be made by an officer below the rank of SI as per prov. of Sec 167(i) Cr.PC
- b) It is held that within the first 15 days period of remand the Magistrate could direct Police custody, but if the investigation was not completed within the first 15 days period of remand no further police remand would be made. It was emphasized that police remand would only made during the first 15 days after arrest and production before the magistrate and not otherwise.

2) The investigating officer has authority to seized / freeze any Bank Account in respect of which investigation is continuing.

State of Orissa & others..... Opp. Parties.

Order passed by Hon'ble I.M. Quddusi A.C.J and Sanju Panda J. of Orissa High Court in (2010) 45 OCR – 50 & WP (Cri) No. 525 of 2009 decided on 22nd October 2009.

Synopsis of the order:-

The Hon'ble High Court held that the investigating authority has in no way violated the constitutional rights of the petitioners as envisaged under Article 19(1) (g) of the constitution of India.

3) When a complaint petition is transmitted by the Magistrate to the Police Station u/s 156(3) of the Cr. P.C, Police can not decide not to conduct investigation on the ground of territorial jurisdiction.

State of Gujrat & others..... Respondents

Order passed by Hon'ble J. Altamas Kabir and his companion J. Cyriac Joseph of Supreme Court of India in (2010) 45 OCR – 559 & Criminal Appeal No. 2041 of 2009 (arising out of SLP (Cri) No. 2915 of 2007 decided on 6th November 2009.

Synopsis of the order:-

The Supreme Court held that the investigating agency was required to place the fact elicited during investigation before the court in order to enable the court to come to a conclusion as to whether it had jurisdiction to entertain the complaint or not. Without conducting such an investigation, it was improper on the part of the Investigating Agency to forward its report with the observation that since the entire cause of action the alleged offence had purported arisen in the city of Mumbai within the state of Maharashtra, the investigation should be transferred to the concerned Police Station in Mumbai. Section 156(3) Cr.PC contemplates a stage where the Ld Magistrate is not convinced as to whether process should issue on the facts disclosed in the complaint. Once the facts are received, it is for the magistrate to decide his next course of action. In this case, there are materials to show that appellant had filed his application for loan with the head office of bank at Ahmedabad and that the proceeding of the sanction of loan was also done in Ahmedabad which clearly indicates that the major part of the cause of action for the complaints arose within the jurisdiction of the Chief Metropolitan Magistrate, Ahmedabad. It is not therefore, desirable on the part of the Investigation Agency to make an observation that it did not have territorial jurisdiction to proceed with the investigation, which was required to be transferred to the Police Station having jurisdiction to do so.

4. Order of Anticipatory Bail remains in force during period of investigation the benefit of the said order is not available after submission of Charge Sheet

Order passed by Hon'ble Justice Altamas Kabir and his companion Justice Dipak Verma of Supreme Court of India (from Madras) in 2010 CRI.L 2293 and Criminal Appeal No 2415 of 2009 (arising out SLP (Cri) No 4190 of 2006 D/16-12-2009.

Synopsis of the order:-

The object of Section 438 Cr.PC had been repeatedly explained by this court and the High Courts to mean that a person should not be harassed or humiliated in order to satisfy the grudge or personal vendetta of the complainant. But at the same time the provisions of section 438 CRPC can not also be invoked to exempt the accused from surrendering to the court after the investigation is complete and it Charge Sheet is filed against him. Such an interpretation would amount to violation to provisions of section 438 Cr.PC, since even though a charge sheet may be filed against an accused and charge is framed against him, he may still not appear before the Court at all even during the trial section 438 Cr.PC contemplates arrest at the state of investigation and provides a mechanism for an accused to be released on bail should he be arrested during the period the investigation. Once the investigation of a case against him and he is included as an accused in the charge sheet the accused has to surrender to the custody of the Court and pray for regular bail. On the strength of an order granting anticipatory bail, and accused against whom charge has been framed can not avoid appearing before the trial Court.

5. Mere physical assault, in the absence of any unlawful demand could not consture the offence under section 498A IPC.

Ref: Resual Islam – Vs- State of West Bengal and others.

Order passed by Hon'ble Justice Sailendra Prasad Talukder of Calcutta High Court in 2010 (3) AICLR and CCR No 3864 of 2007 decided on 15/03/10

Synopsis of the order:-

It is true that the cruelty means any willful conduct of the part of the accused persons which is of such a nature as is likely to drive the women to commit suicide or to cause death injury or danger of life, limb or health (mental/physically) of women. It is clear from the material available in the CD that none of the witnesses, not even the complainant made any statement reflecting such conduct on the part of the petitioner/ accused persons.

Mere physical assault, in the absence of any unlawful demand could not construe the offence under section 498A IPC. There is no such material so as to suggest that there have been willful conduct of such nature of act committed.

Accordingly, I find it default to brush aside the statement made on behalf of the petitioners in the two revisional applications. Though the Ld. Magistrate in the impugned order has dealt wroth the factors and materials relevant for consideration at the stage framing of charge quite well, in absence of anything worth mentioning, I do no think, the Ld Magistrate was justified to direct framing of charge u/s 498A IPC.

Considering all these facts and circumstance of the case and in the light of the discussion as made hereinbefore, the impugned order dated 10th July, 2007 passed by the Ld. Additional Chief Judicial Magistrate, Raiganj, Uttar Dinajpur be set aside and the petitioners/accused persons be discharged. They be released from their respective bail bonds at once.

5. Interesting detections by CID, West Bengal.

1. CID West Bengal Missing File No. 56-2010/ 1/F (89) dt. 13-09-10 was opened over the missing of one Smt. Tumpa Mondal (24 Yrs.) W/o Ananta Mondal, Vill-Purbashapur, PO – Champahati, PS – Sonarpur, Dist – South 24-Parganas since 11-09-10. This has also reference to Sonarpur PS GDE No. 1078 dt. 11-09-10. As usual all informative actions i.e. telecasting, broadcasting and publication in daily leading newspaper were made. From secret information, location of the missing girl was traced in Pune, Maharastra. A team from CID West Bengal went to Pune and with the help of local police, the team of CID, West Bengal recovered the missing lady from Pune on 27/09/2010.

2. One Kumari Kavita Jha (19 Yrs.) D/o Dharmendra Jha of Flat No. 3D, PO – Rajarhat, Dist – North 24-Parganas was reported to have been missing since 28-08-2010. This has reference to New Town PS GDE No. 1429 dt. 28-08-10. The Missing Person Bureau, CID, West Bengal had been informed and subsequently CID, West Bengal Missing File No. 56-2010/1A/F (64) dt. 31-08-10 was opened. In this regard, a specific case had been lodged at New Town PS vide New Town PS Case No. 233 dated 01/09/2010 u/s 363/366 IPC &. It was detected that one Sonu Kumar Pandey S/o Ram Rajya Panday, Vill+PO – Neerleppur, PS – Haldi, Balia (Uttar Pradesh) had kidnapped the girl. Said Sonu Kumar Pandey presented himself as an IPS officer and used to travel by car with red beacon lamp. On a secret information, location of the missing person Kavita Jha was traced at a place “Jaydev” under PS-New Township, Durgapur, District-Burdwan. A team of Special Operation Group, CID, West Bengal comprising of SI Tathagata Pandey, SI Pallab Kumar Ganguly, SI Swarup Kumar Saha, WCT-36 Goutam Bhattacharya alongwith SI P K Shaw of New Town PS held raid at a residential quarter at a place “Jaydev” under PS-New Township, Durgapur, District-Burdwan and apprehended the accused person Sonu Kumar Pandey. The missing girl was subsequently recovered from the same address at Durgapur.
3. One Pratyush Sharma S/o Satish Sharma Radha Madhab Mandir, 527 Dum Dum Park, North 24-Parganas was reported to have been missing since 14-09-10 from his residence. This refers to Lake Town PS GDE No. 607 dt. 12-09-10 and CID, West Bengal Missing File No. 56-2010/1A/M (73) dt. 14-09-10. During enquiry by CID, MPB Section, on a secret information, location of the missing person was detected at Phulbagan area in Kolkata. The area was searched thoroughly and the missing boy has been recovered and handed over to his parent by local Police Station of Kolkata.
4. On 11/08/2010 one Truck bearing Registration Number OR15C-3145 loaded with 484 Pcs. of Aluminium ingots from NALCO, ANGUL, Orissa through Maruti Transport started its journey for delivering the same to Lomino Industries, Jungalpur, Howrah. The consignment did not reach its destination in due time. Over the complaint of Shri Pradip Kumar Swain, owner of the involved vehicle, Sankrail PS Case No. 417 dated 16/08/2010 u/s 409 IPC was registered. During investigation, on secret information, the involvement of one accused namely Subrata Golui @ Bakra (30 years) s/o Lt Basudeb Golui of Madhyakhalia, Chamrail, PS-Liluah, District- Howrah, transpired in this case. On 23/09/2010 the said accused Subrata Golui alongwith one Santosh Jaiswal (30 years) of Madhyakhalia, Chamrail, PS-Liluah, District- Howrah, were arrested. On the basis of their confession, another accused named Sambhu Gupta (38 years) s/o Lt Ramjiban Gupta of 51 A C Banerjee Road, Ariadaha, Lilabati Apartment, PS-Belghoria, District- North 24 Parganas was also arrested. On the basis of their confessional statement, a raid was held by SI Sankar Chandra Das, SI Dipankar Das, SI Chandranath Chakraborty under leadership of Inspector Shri Tapan Kumar Sarkar and Inspector Shri S R Ghosh of Railway & Highway Crime Cell, CID at two Aluminium Factories at Gopal Ghosh Lane under Malipachghora PS, District-Howrah and 1100 Kgs of Aluminium plates and ingots were seized as suspicious

property. The actual stolen properties have been melted away by the suspect. No person has been arrested as yet.

5. On the basis of source information, on 15/09/2010 at 11:00 hrs., officers and men of Nadia DD, organized a raid under the leadership of Inspector Shri Arun Kumar Das of SCU, CID, West Bengal and arrested 1) Sirajul Chowdhury (65 years) s/o Lt Jahur of Number 3 , 14 Rashi , PS- Raidighi, District- South 24 Parganas , 2) Rahim Bari Molla (37 years) s/o Abdul Molla of Number 3 , 14 Rashi , PS- Raidighi, District- South 24 Parganas and 3) Akhtar Molla (33 years) s/o Unis of Baidyapara, PS- Raidighi , District-South 24 Parganas and recovered 230 grams Heroin from their possession. This refers to Kotwali (Nadia) PS Case No. 686 dated 15/09/2010 u/s 21B/29 NDPS Act.
